SPACE RENTAL AGREEMENT ("Agreement")

This Agreement is entered into as of 06/25/2026, by and between:

1. Purpose

The Client grants Operator permission to place and operate a self-service coffee and food kiosk ("Machines") on the premises located at:

751 Three Islands Boulevard, Hallandale Beach, FL 33009

2. Term

This Agreement shall become effective on the date it is signed by both Parties and shall continue on a month-to-month basis unless terminated by either party with 7 days' written notice.

Upon termination, the Operator shall remove all Machines and any and all equipment belonging to the Operator within 15 calendar days.

3. Revenue Share

Operator agrees to share 20% of the gross monthly revenue generated by the kiosk with the Client.

- Payment will be made monthly, no later than the 5th day of each month, for the preceding month's operations.
- Together with each monthly payment, Operator will provide a detailed report along with the payment that includes, but is not limited to, the gross sales and total revenue, number of transactions, sales by product and quantities sold, and a detailed accounting of all operating expenses related to the Machines.
- Operator will provide dashboard access for real-time monitoring.
- Client, or its designated representative, shall have the right upon request to inspect, review, and audit Operator's books and records, relating to this Space Rental Agreement and the Machines. Operator shall cooperate fully with any such audit and shall provide access to all records relating to the Client.
- If any audit or accounting reveals that Operator underreported or underpaid amounts due, Operator shall pay the deficiency with interest at the maximum rate permitted by law from the original due date.

4. Utilities & Access

- The kiosk operates independently and does not require water or sewage access.
- Client agrees to provide standard electrical access.
- Operator will ensure that the kiosk is clean, safe, and does not interfere with daily operations.

5. Maintenance

Upon notification of any malfunction from the Client, the Operator shall remedy the malfunction within three (3) business days.

Operator is fully responsible for: stocking, cleaning, and maintaining the kiosk; customer support and technical service; removing the kiosk upon termination of this agreement. And Operator is fully responsible for any and all repairs or replacements.

If Client requests that a machine or kiosk be replaced, Operator shall replace the machine or kiosk within 10 calendar days of the request. A machine or kiosk may be replaced at anytime upon request from Client.

6. Indemnification

The Operator hereby holds the Client harmless and will defend and indemnify the Client (with an attorney of the Client's choosing), its officers, directors, employees, agents and representatives from and against any and all losses, damages, sums, accounts, liabilities, suits, causes of actions, judgments, demands, payments, claims, penalties, fines, damages, expenses, fees, costs (including, without limitation, attorney's fees and costs through trial and any and all appeals) in connection with any Machines that are subject to this Agreement, this Agreement, and any other matters between the Parties.

7. Insurance

The Operator will carry general liability insurance in an amount not less than \$500,000 per incident during the term of this Agreement and any all renewals of this Agreement. Such insurance shall be issued by a carrier with no less than an A+ rating from A.M. Best or similar underwriter and shall name the Client as an additional insured.

8. Miscellaneous

The Operator shall comply with all applicable federal, state, and local laws and regulations, including but not limited to, food service and vending machine operations.

This Agreement represents the entire understanding between the Parties and supersedes all prior discussions or agreements.

In connection with any litigation arising out of or relating to this Agreement, the prevailing party shall be entitled to recover from the non-prevailing party said prevailing party's attorney's fees and costs, including, without limitation, attorney's fees and costs through trial and any and all appellate proceedings. Venue for any action relating to this Agreement shall be exclusively and solely in courts having jurisdiction over Broward Dade County, Florida.

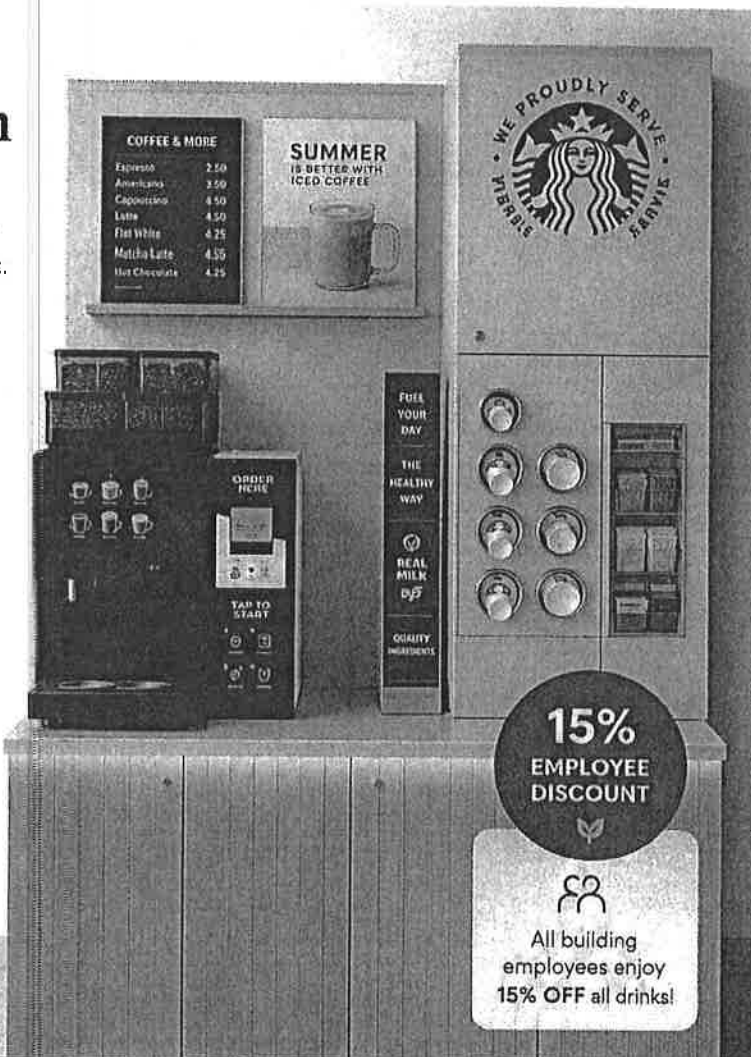

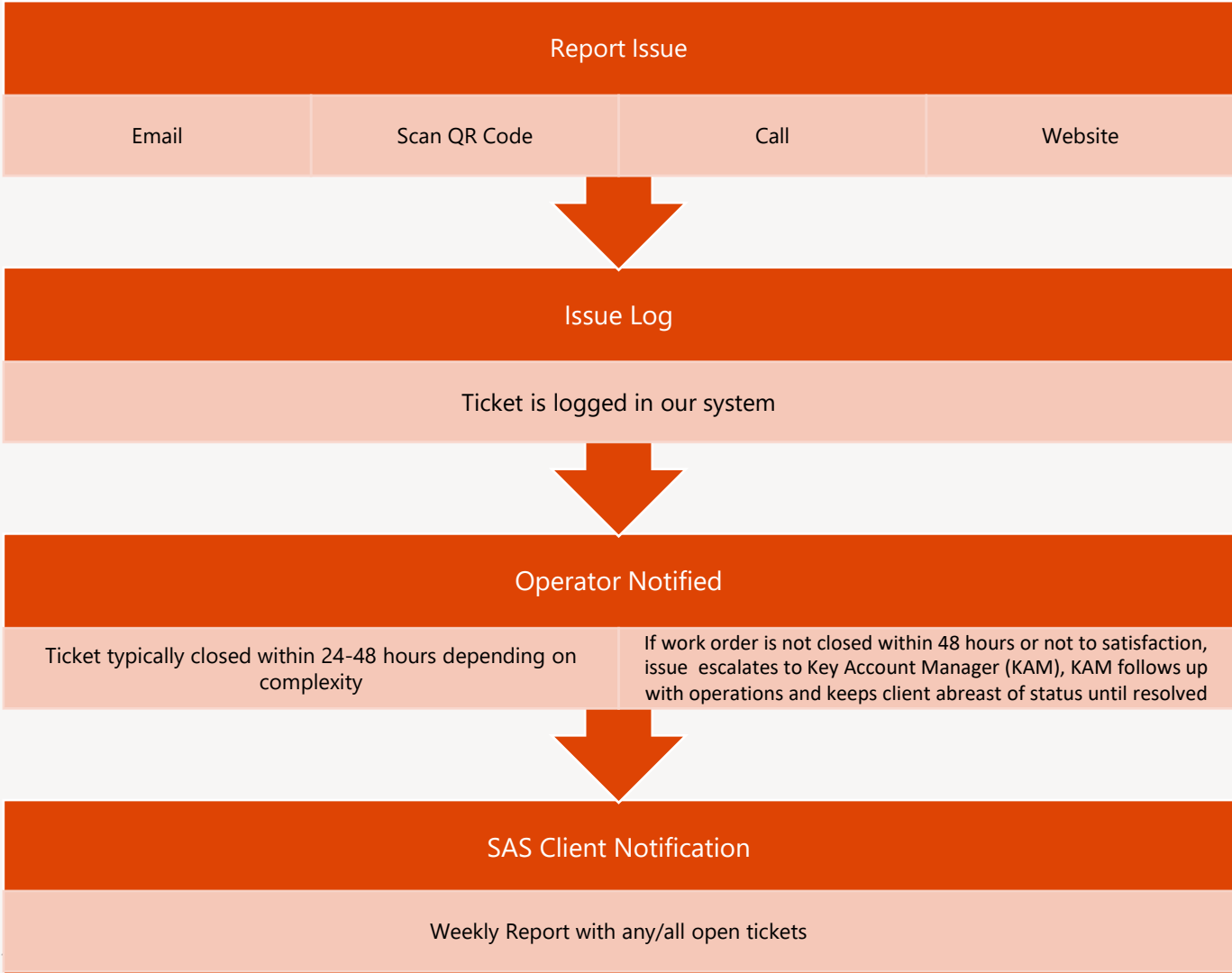
